

Payment and Refunding Policy

All tuition fees are payable in advance of attendance and are in accordance with the fee structure established by Flexi International e-School.

1) Registration Fee:

This is unified to all grades, **\$110** is payable upon applying for admission to Flexi International e-School, which is non-refundable, non-transferable, and non-adjustable.

2) Entry/Admissions Fee:

This is unified to all grades, **\$500** is payable upon admission, and before enrollment, which is non-refundable, non-transferable, and non-adjustable. Admission Fee has been waved for students applying for the academic year 2021-2022.

3) Placement Test Fee:

- a) Placement Test fees is **FREE** if taken for the first time, and is chargeable **\$50** thereafter. Such fee is payable before offered a place, non-refundable, non-transferable, and non-adjustable.
- b) If a student joins the school in the middle of a quadmester/semester, applicable tuition fees will be prorated, based on the number of full weeks (commencing from the week of joining) remaining and unexpired in the quadmester/semester.
- c) All forms of payment methods are acceptable; however, online payment at the school payment gateway is recommended for quick access to student account after payment.

4) Non-payment of Fees

Failure to pay school fees may result in a loss of the student's place in the school, withholding of their school reports, references, and/or examination results, as well as, temporary or permanent expulsion or exclusion from school.

5) Refunds

The registration fee, admission fee, and re-enrolment fee remain non-refundable. Tuition fee refunding is allowed, if a student withdraws or is suspended, regardless the reasons. Refunds will be processed as follows and returned to the same payee.

- a) If a student withdraws prior to the start of the academic year, the balance of the first term/semester fee will be refunded, except the Registration Fee and the Admissions Fee, which is a one-time, non-deductible.
- b) If a student withdraws during a quadmester/semester, the Registration fee, Admission fee, and Re-Enrolment fee, are non-refundable, and the remaining tuition is refunded as follows:
 - 1. For Yearly Payment Plan, fees will be charged for One Full Month if withdrawal/suspension takes place after the start of the school year.
 - 2. For Yearly Payment Plan, full fees will be refunded, deducting attended period by student in addition to the current month of withdrawal/suspension.
 - 3. For Monthly Payment Plan, no refunding will take place if withdrawal/suspension takes place after the school year starts.

6) Re-Enrolments

In order to secure seats for next academic year, parents may be asked to pay a reenrolment fee of 10% of the annual school fee, which is non-refundable, but adjustable against the tuition fees.

7) Withdrawal Procedures

In case a student would like to withdraw from the school, guardian must complete the Withdrawal Form, which could be requested at the Student Affairs department. A 30-day notification period is required to ensure all necessary documents are ready if any to be due.
